## **Safeguarding Adults Week – multi-agency training Monday 21 November – Friday 25 November 2022**

### **Allegations management (adults)**

Monday 21 November 10:00am – 12:00pm

Virtual

The Allegations Management Process for adult services helps employers and leaders of voluntary groups deal effectively and professionally with any allegations made against their employees or volunteers. The allegations management training explains the thresholds for when the process should be used, explains your employer or group leader responsibilities and the actions that should be taken, as well as giving details of how the system works once a report is made and the involvement of other agencies such as the police. The allegations management training also covers the Safer Working Practices Guidelines. These have been produced to help practitioners establish the safest possible working environments which safeguard individuals and reduce the risk of being falsely accused of improper or unprofessional conduct. The course is recommended for employers in adult services and leaders of groups who work with adults with care and support needs.

### **Mental Capacity Act and the Deprivation of Liberty Safeguards (MCA/DoLS)**

This course will enable participants to improve their awareness of the Mental Capacity Act and the Deprivation of Liberty Safeguards. This webinar is appropriate for all professionals working with adults who lack or may lack capacity in the health and social care sectors and who may therefore be at risk of abuse or neglect

## **Cuckooing / home invasion**

Cuckooing or home invasion is a term that we are hearing more and more frequently. Put simply, it is the practice of exploiting a vulnerable person, in order to use their property. As awareness of cuckooing rises, there is more of a demand on housing providers and councils to play a part in addressing the issues in partnership with police colleagues. The Partnership Enforcement Team (PET) use their practical experience to demonstrate the different types of cuckooing using local case studies. Attendees will come away with a real insight into this growing problem and guidance on what to do if they have concerns.

## **Self-neglect and hoarding**
